Dominique RIQUET – Chairman of the Long Term Investment Intergroup

Elected at the European Parliament in 2014 for a second mandate, Dominique Riquet is the first Vice-Chair of the transport and tourism committee and a member of the industry, research and energy committee.

As a member of the UDI (Union des Démocrates et Indépendants) in France, he joined the ALDE (Alliance of Liberals and Democrats for Europe) within the European

Parliament. Particularly involved in infrastructure financing, he was rapporteur on the Connecting Europe Facility and he is currently rapporteur for opinion on the European Fund for Strategic Investments ("Juncker Plan"). In the meantime, he has become the founder and chairman of the intergroup on long-term investment and reindustrialisation (#Invest4Future). Prior to that, he was Regional Councillor for the Nord Pas-de-Calais region (1992-2009) and he also served for ten years as the mayor of Valenciennes (2002-2012) following Jean-Louis Borloo. Born in 1946, Dominique Riquet holds a degree in general medicine and a degree in urological surgery.



Denis DUVERNE, Chairman of the Board of Directors of AXA, Vice-Chairman of the European Financial Services Round Table

From September 1st, 2016, Denis Duverne (62) has become Non-Executive Chairman of the Board of Directors of AXA. Since April 2010, Denis Duverne has been a member of the Board and Deputy Chief Executive Officer ("Directeur général délégué") of AXA. He started his career in 1979 at the tax department of the French Ministry of Finance, and, after 2 years as commercial counselor for the French Consulate General in New York, he was director of the Corporate Taxes Department and then responsible for tax policy within the French Ministry of Finance from 1986 to 1991. Between 1991 and

1995, he held senior positions in the banking sector. Denis Duverne joined the AXA Group in 1995 and assumed responsibility for supervision of AXA's operations in the US and the UK before managing the reorganization of AXA's companies in Belgium and the United Kingdom following the merger with UAP.

Between 2000 and 2003, he became Deputy Chief Financial Officer, where he developed in particular the risk management function. From February 2003, he was the Management Board member in charge of Finance, Control and Strategy. He was notably in charge of the integration of Winterthur within the AXA Group in 2006-2007. In 2014, Denis Duverne became a member of the Private Sector Advisory Group (PSAG), which brings together international leaders of the private sector whose shared goal is to help developing countries improve their corporate governance, co-founded in 1999 by the World Bank and the Organization for Economic Co-operation and Development (OECD). Denis Duverne is a graduate of the École des Hautes Études Commerciales (HEC) and of the École Nationale d'Administration (ENA).



Valdis DOMBROVSKIS, Vice-President for the Euro and Social Dialogue, also in charge of Financial Stability, Financial Services and Capital Markets Union, European Commission

Valdis Dombrovskis is the Vice-President of the European Commission responsible for the Euro and Social Dialogue, also in charge of Financial Stability, Financial Services and the Capital Markets Union.

Prior to that, he served three consecutive terms as Prime Minister of Latvia, becoming the longest serving elected head of government in Latvia's history. Before becoming European Commission Vice-President, Valdis Dombrovskis was elected for the second time as a Member of the European Parliament (first, 2004-2009) and Head of the Latvian Delegation in the EPP Group. He served as a Member of the Saeima (Parliament) of Latvia (March 2004 - June 2004; January 2014 - June 2014) and was Latvia's Minister of Finance from 2002 to 2004.

Valdis Dombrovskis was born on 5 August 1971 in Riga, Latvia. He graduated with a degree in physics from the University of Latvia (1993) and economics from Riga University of Technology (1995). He received his master's degree in physics in 1995 from the University of Latvia. In 1995 -1998, he worked as a research assistant at Mainz University, Germany, at the Institute of Solid-State Physics in Latvia and at the University of Maryland (USA).

Prior to joining politics, he worked as a senior economist and Chief Economist at the Bank of Latvia (1998-2002). Together with Anders Aslund, he co-authored the book "How Latvia came through the financial crisis", which was published in 2011. In November 2014, Valdis Dombrovskis was awarded the Order of the Three Stars (*Triju Zvaigžņu ordenis*), the highest State Decoration of the Republic of Latvia.



Sir Adrian MONTAGUE, Chairman of Aviva, Chair of the European Financial Services Round Table's working group on Climate Change

Appointed to the board of Aviva plc in January 2013, Sir Adrian Montague became senior independent non-executive director in May 2013 and Chairman in April 2015. Sir Adrian brings his significant experience of the financial services industry and in government and regulatory circles to the Board. He is currently Chairman of The Manchester Airport Group plc (airport operator) and The Point of Care Foundation (charity). He is a Non-Executive Director of Cellmark Holdings AB (forest products).

Sir Adrian was formerly Chairman of Anglian Water Group Ltd (utilities), Friends Provident plc (life insurance), British Energy Group plc (utilities), Michael Page International plc (recruitment), and Cross London Rail Links Ltd (Crossrail), and was formerly Deputy-Chairman of Network Rail Ltd (railway network authority), Partnerships UK plc (public private partnership) and UK Green Investment Bank plc (investment bank). He was also previously Chief Executive of the Treasury Taskforce and a trustee of Historic Royal Palaces.



Mikolaj DOWGIELEWICZ, Permanent Representative of the European Investment Bank to the European Union

From 1998 to 2000, he worked in the Cabinet of the Minister of Foreign Affairs, Bronislaw Geremek. In 2003, he began to work in Brussels as an adviser on enlargement to Pat Cox, President of the European Parliament. In 2004, he became European Commission spokesman for Institutional Relations and Communication Strategy and, in 2007, entered the Cabinet of the Vice-President of the European Commission, Margot Wallström. In December 2007, he was appointed Secretary of State in the Office of the Committee for European Integration (OCEI). As of July 2008, he was appointed to the position of Government Plenipotentiary for Presidency of the EU Council. In January 2010, after the OCEI and the Ministry of Foreign Affairs were merged, he became Secretary of State for European Affairs

and Economic Policy at the Ministry of Foreign Affairs.

Between 2007 and 2012, he chaired the Polish Government's Committee for European Affairs. While in government, Mikołaj Dowgielewicz represented Poland on the EU General Affairs Council, which he chaired in the second half of 2011 during the Polish Presidency of the Council.

In March 2012, he was unanimously elected Vice-Governor of the CEB by the Bank's 40 Member States. In 2012, Mikołaj Dowgielewicz was decorated with the Officer's Cross of the Order of Polonia Restituta by the President of Poland. He has also been awarded the insignia of Commander by Number (Encomienda de Numero) of the Order of Isabella the Catholic by the King of Spain and has received the Commander's Cross Order of Merit of the Republic of Hungary. In 2012, he received the Wladyslaw Grabski award of the Polish Confederation of Private Employers Lewiatan.

On the 1st of September 2015 he was appointed
