




Rockstrom's "planetary boundaries concept": a set of nine planetary boundaries **within** which humanity can continue to develop and thrive for generations to come.





For Invest-NL, ESG is an inherent part of sustainable value creation.







Value creation through ESG at Invest-NL

- 1. Pre-investment we screen our investments on key ESG risks, depending on the sector
- 2. We conduct ESG assessments on and with our portfolio companies to identify areas of improvement- we partner with an external specialist party
- 3. We set engagement targets & follow up on these with our portfolio companies throughout our investment period
- 4. We belief that in this way we can be a partner for sustainable growth for our portfolio companies
