The Technical Support Instrument at a glance



What is the Technical Support Instrument?

- Provides tailor-made technical expertise to EU Member States to design and implement reforms.
- Support is upon request and does not require any co-financing
- An important pillar of the EU recovery plan
- Can cover all reform phases, from design to implementation and evaluation.





Flagship technical support projects

Definition

- Flagship technical support projects are projects proactively proposed by DG REFORM that:
 - Are largely needed across Member States
 - Meet a top EU / Commission priority
 - Are designed in a way that can easily be fitted to various national contexts
 - Their uptake is voluntary



Flagship technical support projects

Format

- Flagship technical support projects:
 - May be taken up individually by different Member States or jointly as a multi-country project;
 - May comprise technical support modules that Member States can opt-in and be tailored-made to national context

For TSI 2022, we are proposing 13 flagship technical support projects



Flagship technical support projects



- Two successful Flagships have been implemented so far:
 - Support for the preparation of Just Transition Plans (2020): timely and effective support on a key EU priority, rolled out in parallel across 17 Member States
 - Green budgeting training (2021): capacity building actions to support Member States in their efforts in greening public finances in line with the EU Green Deal; 18 Member States expressed interest

Flagship Technical Support project: Support to the implementation of the Just Transition

- Objective: support the implementation of a Just Transition for regions affected by the transition to climate neutrality.
- Three technical support packages that Member States and regions can choose from and tailor to the national and local contexts:

SUPPORT TO NATIONAL PROMOTIONAL BANKS FOR PILLAR 2 UNDER THE JTM

 Capacity building and advice for the implementation of the dedicated InvestEU Just Transition scheme

OTHER SPECIFIC NEEDS ON THE IMPLEMENTATION OF THE JTM

 Complementary administrative and regulatory reforms in the most affected regions, not covered by available technical assistance streams

JUST TRANSITION IN REGIONS AND SECTORS NOT COVERED BY THE JTM

 Just transition challenges in areas or sectors that are not covered by the JTM, but that nevertheless may face significant economic, social and environmental impacts of the climate transition





Support to the implementation of Pillar 2 Just Transition Mechanism

INVESTEU "JUST TRANSITION" SCHEME – PILLAR 2

 The InvestEU Fund provides an EU budget guarantee of €26.2 billion aimed at increasing the risk-bearing capacity of implementing partners. The budget guarantee is divided among 4 policy windows:

- The InvestEU Just Transition Scheme will support investments that address social, economic and environmental challenges deriving from the transition towards achieving of EU's 2030 and 2050 climate targets.
- Investments in just transition regions or which benefit just transition regions, will be possible through any of the InvestEU policy windows, depending on the specific investment needs identified by Member States in their territorial just transition plans i.e. sectors and activities envisaged to be supported.



Support to the implementation of Pillar 2 Just Transition Mechanism

ROLE OF NATIONAL PROMOTIONAL BANKS (NPBs)

- NPBs will play a key role, alongside the European Investment Bank Group, in ensuring these investments materialize in the most affected regions.
- As Eligible InvestEU Implementing Partners, NPBs will have direct access to the EU guarantee.
- Project promoters, with projects in the regions having an approved transition plan or projects that benefit those regions, will be able to apply directly to implementing partners who will offer tailor-made financing solutions based on the financial products supported by the EU guarantee.





Support to the implementation of the Just Transition

IDENTIFIED SUPPORT MEASURES

The flagship focusses on ways to **support NPBS to implement the Just Transition on the ground** via the Just Transition Scheme.

For instance, DG REFORM can provide support to NPBs to:

DEVELOP FINANCIAL PRODUCTS
SUPPORTED BY EU GUARANTEE

DEVELOP A METHODOLOGY TO ASSESS THE ECONOMIC, CLIMATE AND ENVIRONMENTAL IMPACTS OF PROJECTS

TRACK AND REPORT ON THE FINANCING AND INVESTMENT OPERATIONS

IDENTIFY BARRIERS AND
OPPORTUNITIES FOR FINANCING
JUST TRANSITION PROJECTS

DEFINE A JUST TRANSITION INVESTMENT STRATEGY

CONDUCT MARKET RESEARCH
TO ASSESS INVESTORS' APPETITE
