

Capacity Building Strategy for the Practitioners of Technology Transfer in Europe Launch Event - 10 December 2015, Brussels

Briefing document

Venue: European Commission, 21 rue du Champs de Mars, 1050, Brussels

Context:

Building the capacity of the European Technology Transfer ecosystem has been the aim an ever increasing number of initiatives over the last few years. Actors of the ecosystem generally agree that practitioners to be efficient in transferring research outputs to market need access to a body of tested and validated knowledge and tools. And indeed these many initiatives have produced a wealth of knowledge, tools and methodologies; however they are a fragmented set of instruments, lacking a coherent framework, accessibility and any clear plans to be further developed and leveraged.

The Capacity Building Strategy for the Practitioners of Technology Transfer in Europe (CBS)¹ proposes to help rationalise the capacity building effort Europe-wide by suggesting to use a conceptual structure for future initiatives to be developed; by detailing a number of priority areas in which capacity building initiatives are likely to have the greatest impact; and by proposing specific capacity building actions which could be worth exploring as part of sub-strategies of the wider CBS. Based on the above, the event on 10th December 2015 in Brussels will mark the end of the preparatory research and consultation work and officially launch the CBS. During a short brainstorming session, participants will be asked to go a step further and start implementing the CBS.

Objectives of event:

- Officially launch the Capacity Building Strategy;
- Kick off a process of coordination of a capacity building effort within the CBS framework and priority opportunity areas;
- Brainstorm how the impact of existing capacity building initiatives could be increased and identify any gaps for further Capacity Building sub-strategies;
- Agree an action plan for monitoring the impact of the CBS.

Building the Capacity of the European TT ecosystem – leveraging synergies, identifying gaps

The CBS is an integrated endeavour, aiming, through various sub-strategies such as the PROGRESS-TT strategy and others to come, at helping all key stakeholders – including policy makers at European, national or regional levels, public research organisations, associations of technology transfer organisations and individual practitioners, be they on the offer or on the demand side, and investors – identify points of actions where they have the highest chance of increasing technology transfer capacity. Participants will be split in three groups representing the complete TT ecosystem (please see pages 3 and 4 for the list):

- Group 1: Policy-makers (TT environment-side)
- Group 2: TT Practitioners selling IP (Offer-side/IP production)
- Group 3: TT Practitioners buying IP (Demand-side/Financing)
- Work in group around topic (60 min incl. 10 min break) discuss the possibility of:
 - Increasing impact of current initiatives and leveraging synergies between organisations²;Questions to be answered:
 - How can the lessons and legacy of previous initiatives be better leveraged?
 If so which one and how?
 - Could impact be increased if some of these initiatives were delivered jointly?
 If so which one and how?
 - Identifying gaps: Shaping new CB sub-strategies; Questions to be answered:
 - Are there any other initiatives existing elsewhere in the world (or missed in the list) that should be added or used as inspiration?
 - Are there any gaps you've spotted in the recent or current landscape of initiatives as listed in the CBS annex 1?
 - If gaps are identified, how could these be filled?
 - Who should lead on the new initiative and how (action plan)?
